PA Home Energy RESNET/ BPI Training Incentives



PROGRAM OVERVIEW

PA Home Energy integrates the general principles of whole house performance with green home design. At the heart of PA Home Energy is ENERGY STAR, a powerful brand widely recognized by consumers. PA Home Energy is based on the ENERGY STAR Qualified New Homes and Home Performance with ENERGY STAR (existing homes) programs. Financial incentives of \$200 to \$1000 will be made available to homeowners within Allegheny Power's 23-county service region, which utilize PA Home Energy qualified service providers to certify the construction of their new home or make energy improvements to their existing home. Contractors will be trained and certified to nationally recognized RESNET and BPI standards..

FINANCIAL INCENTIVES FOR CONTRACTORS AND CONSULTANTS

PA Home Energy is providing financial incentives to Pennsylvania contractors and consultants who wish to obtain RESNET and BPI certification to support the PA Home Energy program. These financial incentives are being provided by the West Penn Power Sustainable Energy Fund (WPPSEF).

Completion of training and testing (\$200 RESNET training + \$200 BPI training)

- Provided to any PA-based builder, contractor, or consultant that completes the training and takes the test (limit 2/ company).

Early adopter incentives (\$500)

- Provided to any PA Home Energy Service Provider that performs and submits reporting on five PA Home Energy existing home audits/new home plan reviews anywhere in Pennsylvania. These audits/plan reviews must be completed within 120 days of listing as a service provider (limit 2 per company).
